A. Welcome

D. School Trustee Report

Judi Hunter

I trust everyone had a fabulous summer break, the weather was super and summer is such a good time to reconnect with family and friends. As we head back to school, I have seen parents and children out buying new clothes, school supplies and getting their heads around the early mornings and changes in routines.

Rockyview School Board is moving to a cashless system. School Cash online reduces administration at schools. Rocky View Schools have been using School Cash for years and the majority of fees are paid online. Reducing the amount of cash that is brought to schools provides our school staff with time to teach and support children.

This is a jurisdictional initiative and not just a school initiative.

To help ensure safety for all involved in the learning environment, Ministerial Order No. 039/2019 Seclusion and Physical Restraint in Schools and Time-out in Schools Standards that is effective September 1, 2019, until October 31, 2019 has been signed. This ministerial order identifies the Standards for Time-out in Alberta Schools, and Standards for Seclusion and Physical Restraint in Alberta Schools documents as the basis for school authorities to develop policies, procedures and practices.

None of the 7 new modulars would be ready by September 1. They will be released to RVS from the manufacturer starting mid-September with the last one ready in late October. Once released to RVS

we still need to transport them to the appropriate site and then get them connected to the school before they can be used. That delivery and setup takes an additional 4-6 weeks once released.

The 7 new modulars are scheduled to go:

1 for Windsong Heights

1 for RancheView

3 for Chestermere Lake Middle

2 for Prairie Waters

The government is passing the Education Act to replace the School Act. A e-copy of the Education Act can be found at <https://open.alberta.ca/publications/e00p3>. Trustees are currently reviewing the changes to determine the impact on our school division. M

Schools Boards have not yet received funding information for the current year. Trustees have created a cautious budget to mitigate possible negative consequences of budget cuts should that happen. The ability to charge for bus fees will also be considered. The bus routes have been reduced by 24 which means that the average time on the bus for kids also increased.

1. Principal's Report

École Elbow Valley School Council Meeting

September 10th, 7pm

The new hallway paint, carpet and refresh of the washrooms were also highlighted as projects undertaken over the summer.

Every parent should have received a sign up for MyBlueprint which is your online student portfolio where certain projects your son or daughter does will be diarized throughout the email. There are some issues with the application where only 1 student per family can be registered and the company is troubleshooting this. It was suggested that parents be reminded of this in the weekly newsletter. It would also be beneficial if the app provided notification to check for new files and it was recommended that parents provide this feedback directly to the company in hopes they will enhance the functionality. It is a great tool that allows learning and filming to transfer from school to home. MyBlueprint is intended to compliment PowerSchool and it is recommended that parents access both. All teachers are being encouraged to use MyBlueprint, some will use it more than others, but everyone will eventually use it.

Next year, Elbow Valley will be moving fully to online reporting (very 2 week progress report) versus report cards sent home a few times per year. When the transition to online reporting is done next year, there will be only one report card at the end of the year sent home compared to this year where 3 report cards are sent home. The goal of reporting progress every 2 weeks is that there are no surprises when a report card is sent home at the end of the year.

It was noted that PowerSchool is not geared towards elementary schools and some adjustments had to be made to accommodate elementary school learning. The notion of online reporting every 2 weeks is a learning curve for teachers and parents which is why it was phased in across RockyView Schools.

It was recommended that some of these tools be covered in a lunch and learn or the coffee and Kleenex session at the start of the year as it would be helpful especially for new parents.

There will be different themes related to House Teams throughout the year including responsibility, empathy, resiliency and gratitude. The first theme is responsibility and students will get beads for being responsible which will be pooled together. The House Teams will be encouraged to work together as much as they compete against each other. Brendan welcomed all parents to the planned House Team assemblies including the one tomorrow.

There is some efforts to redesign the learning space. Students will be engaged into the process and a committee has been established. The inspiration is a book called "The Space" by Rebecca Louie Hare focusing across the school on 3 things everyone can do without as the staff are challenges to create addition by subtraction.

There will be no numeracy residency this year to allow time to apply the many ideas which were generated from the residency last year. This will allow teachers some time to focus on some key areas.

The financial priorities for this year will be shared at the October school council meeting including potential opportunities for badminton and a self-regulation course.

The Power Words are all completed in French and the job has been started in English. It saved a lot of money recruiting volunteers and doing the work themselves. The focus is on the key words most commonly used and they are put in a ring for students to reference.

Brendan shared with Tina the playground report life expectancy summary and encouraged everyone to review the school council meeting minutes when they are posted on the web site.

There was a question brought forward about Engineering for Kids and Brendan said they are assessing how to offer it to grade 1 and 2 students as there were some issues with maturity and ensuring kids are in the right location last year. The younger children needed more supervision than was planned for last year. The school staff are looking at various options as it is not convenient for parents to have one child in grade 3 or 4 in the sessions and one child taking the bus home. Parents may be advised they have to pick up children early if they are not well behaved. Brendan is meeting with the Engineering for Kids coordinator and will advise as to next steps.

There was a general discussion around how open the school and parents would be for more fundraising while ensuring we don't have fundraising fatigue with multiple asks for money throughout the year. The general guidelines are no rewards and no door to door activities. There is also no mandate for parents to raise money but it does enhance the value of the school. It was suggested that fundraising for community should also be considered in an effort to teach kids the value of giving back. There will also be the school casino on October 14/15 which will require school volunteers.

It was suggested that more school council meetings are in the evening and that there is also a volunteer orientation scheduled for the evening in addition to the afternoon. School council meetings will be shifted to alternating between afternoon and evening and there will be 2 volunteer orientations scheduled.
